Required Qualifications for awards. Applicants must:

- Be admitted to the incoming class of the Broad Executive MBA.
- Demonstrate their capacity to achieve educational and professional goals, as well as the initiative to seek opportunities that will further their educational and professional success.
- Not be receiving full financial sponsorship or educational reimbursement from their employer or any other entity.
- Agree to have their Executive MBA application reviewed by the selection committee.

To apply for the scholarship:

- Complete this Application Form in its entirety (including all applicable essays) and send to Sarah Ellis in the Broad Executive MBA Office via e-mail (sellis@broad.msu.edu) or US mail.
- Obtain one (1) Letter of Recommendation, specifically speaking to your collaborative leadership, hardworking excellence, and commitment to personal and professional growth. This recommendation is different and in addition to those included in your Broad Executive MBA application.
- Letter of Recommendation should be addressed to the Broad Executive MBA Scholarship Committee and sent directly to Sarah Ellis in the Broad Executive MBA Office via e-mail (sellis@broad.msu.edu) or US mail.

Award Amounts

The Broad Executive MBA program admission committee awards a limited number of partial scholarships during the admission cycle. The scholarship decisions are based on a holistic review of the completed scholarship application.

Award Policies

A Scholarship Committee will make recommendations for appropriate scholarship recipients. All applicants will receive notification of the committee's decision. Scholarships will be credited as appropriate to the recipient's MSU tuition account.

Obligations of the Scholarship Recipient

Scholarship recipients are required to confirm acceptance of the scholarship and attendance in the EMBA program via an Acceptance Letter provided by the Executive MBA Program Office. This must be done within 30 days of award notification. If a recipient's situation changes so that he/she is no longer qualified to accept the scholarship, the scholarship support will terminate.

Publicity of the Scholarship

The Executive MBA Program and Michigan State University will publicize the Scholarship in accordance with university and program policies.
